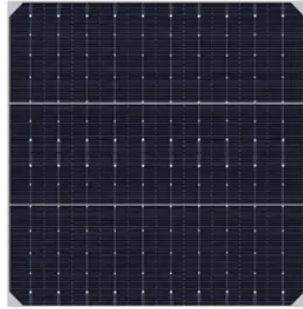




The newly bought house has solar panels on the roof
